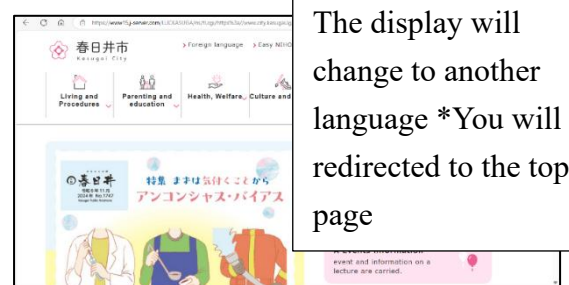

## 6 Learning Japanese

## 7 Health Insurance and Pension System

Health Insurance, Medical Aid and Pension Section

### Health Insurance

There are two types of health insurance: social insurance (*shakai hoken*), which is arranged through your workplace, and national health insurance (*kokumin kenko hoken*) or the Older Seniors Healthcare System (*koki koreisha iryo seido*).

#### <National Health Insurance>

People who are registered in the Residential Basic Book (*jumin kihon daicho*) and staying for purposes other than (i) activities to receive medical treatment or activities to provide daily care for those engaged in activities to receive medical treatment, and (ii) sightseeing, recreation, or other similar activities for a period not exceeding one year, or accompaniment as spouses, but who are not qualified to enroll in other forms of health insurance are required to enroll in the national health insurance (*kokumin kenko hoken*).

1. Health Insurance premiums are determined according to the number of people enrolled in your household and their income.
2. When receiving treatment at a hospital, please remember to bring your insurance card, eligibility confirmation letter, or my number insurance card with you to the hospital.

#### <Older Seniors Healthcare System (*koki koreisha iryo seido*)>

The Older Seniors Healthcare System covers people aged 75 or over (or 65 or over for people with certain specific disabilities).

People who are registered in the Residential Basic Book and staying for purposes other than (i) activities to receive medical treatment or activities to provide daily care for those engaged in activities to receive medical treatment, and (ii) sightseeing, recreation, or other similar activities for a period not exceeding one year, or accompaniment as spouses are automatically enrolled in the Older Seniors Healthcare System on their 75<sup>th</sup> birthday.

Also, people aged 65 or over with certain specific disabilities may choose to enroll in the Older Seniors Healthcare System if registered in the Residential Basic Book and staying for purposes other than sightseeing, recreation, or other similar activities by submitting their Physically Disabled Persons Handbook or other document confirming the state of their disability.

1. Insurance premiums are determined on an individual basis by adding up the "Insured person per capita amount," which is paid equally by all insured persons, and the "Income-based amount," which is paid according to income.
2. When receiving treatment at a hospital, please remember to bring your insurance card, eligibility confirmation letter, or my number insurance card with you to the hospital. (Until July 31, 2025, a qualification confirmation form will be mailed after the enrollment paperwork is processed.)

### <Health Checkups, etc.>

People aged between 40 and 74 who are covered by the national health insurance system are offered special health checkups in order to help early detection and treatment of those suffering from diabetes or hypertension (high blood pressure) and those at risk of the disorders. As a result, special health guidance will be provided to people requiring health guidance.

### Public Pension System

Residents in Japan aged between 20 and 59 (inclusive) are obliged to enroll in the Japanese public pension system, regardless of whether or not they have Japanese nationality.

The pension service is carried out by the Japan Pension Service commissioned by the Ministry of Health, Labour and Welfare. Please inquire with the Japan Pension Service Office for details.

## 8 Nursing Care and Welfare Measures for Persons with Disabilities

### <Nursing Care Insurance System (*kaigo hoken seido*)>

Nursing and Elderly Welfare Section

If you fall under either of the following categories, you are entitled to receive services through the Long-term Care Insurance system, subject to approval of the municipal government.

- (1) People aged 65 or over who are registered in the Residential Basic Book, excluding those who stay in Japan only for a short period of time.
- (2) People aged between 40 and 64 (inclusive) who are enrolled in a health insurance system  
(When nursing care is required due to a disease specified by law (specific disease))

To receive services through the Long-term Care Insurance system, first contact the local community comprehensive support center or in-home care support provider.

The care service provider will consult with the person who needs care services and his or her family members to determine the type, timing and frequency of service and develop a care plan based on the kind of care service required.

## 10 Weekday Nighttime and Holiday Emergency Medical Care

- (1) If you or any of your family members should fall ill at night or on a holiday, contact your family doctor, who has your and your family member's medical data and who thus can provide appropriate treatment from a holistic perspective.
- (2) If you cannot reach your family doctor, you can receive treatment at the emergency medical institution (for holidays and night hours on week days) shown below.

Please be sure to check the medical service hours, etc. and to call the medical institution before visiting.

**<Nursery Schools, Centers for Early Childhood Education and Care (*nintei kodomo-en*) and Small-Scale Nurseries (*shokibo hoikuen*)>**

Nursery Schools are child welfare institutions that integrally offer protective care and education on behalf of parents or guardians when children, who are generally aged between six months and preschool age, need full-time nursing care for reasons such as work or due to nursing a sick family member.

Centers for Early Childhood Education and Care are institutions that comprehensively offer education and day care for preschoolers and have functions and traits of both a kindergarten and a nursery.

Small-Scale Nurseries are a type of nursery enterprise authorized by the city that care for children in place of the parents just like Nursery Schools do. These institutions provide care to groups of 6 to 19 children aged zero to under three years.

**[Routine Vaccination]**

Recommended vaccines and their recommended doses vary with the age of children. Vaccination coupons will be mailed to eligible children. Please make a vaccination reservation for your children at a designated medical institution in the city. When bringing your children to get vaccinated, please bring the coupon and your Mother

and Child Health Handbook to the institution. If you lose the coupon or hope to have your children vaccinated at a medical institution outside Kasugai City, you must complete the necessary procedures in advance at the Health Promotion Section.

The City pays part of the cost of mumps vaccinations for preschoolers aged one to six years on the day of the vaccination.

Upon the submission of a notification of pregnancy, a Mother and Child Health Handbook (a Japanese version or foreign language version) will be issued at the Children and Family Support Section (City Hall 2nd floor, General Health Care Center 3rd floor). The Guidebook for Mother and Child, a separate volume (a health checkup, etc. examination slip for an expectant or nursing mother and an infant), will also be issued for target individuals.

If you are eligible, you will receive a coupon by mail.

### [Rubella]

Rubella antibody tests and vaccinations are offered free of charge to men born from April 2, 1962 to April 1, 1979. (until March 2025)

Furthermore, the City pays part of the expense of rubella vaccinations for officially married couples expecting or hoping for pregnancy and husbands of pregnant women.

\* This coverage is subject to certain conditions.

### [Influenza]

Vaccinations are offered to persons aged 65 or older on the day of the vaccination, provided that they pay part of their own vaccination expenses. (There is a fixed period during which you can receive the vaccination.)

### [Streptococcus pneumonia (Pneumococcus)]

Vaccinations are offered to persons who are the age of 65 on the day of the vaccination, provided that they pay part of their own vaccination expenses. Eligible people will receive a postcard about their vaccinations.

In addition to the above, there is also a system in which the City pays part of the expense of pneumococcal vaccinations for those aged 65 or older on the day of the vaccination.

\* This coverage is subject to certain conditions.

### [COVID-19]

People who are 65 years of age or older on the day of vaccination can receive the vaccination by paying part of the vaccination cost themselves. (There is a fixed period during which you can receive the vaccination.)

### [Shingles (Herpes zoster)]

The City pays part of the expense of shingles vaccinations for people aged 50 years or older on the day of the vaccination. There are two types of shingles vaccines; eligible people are advised to consult a doctor about which vaccine to choose.

## 13 Fire

In case of fire, report it by dialing 119.

### Example phone conversation

Operator: Fire or ambulance?

Caller: Fire

Operator: What's the address of the fire?

Caller: 1-1 X Town, it's X nursing home.

Operator: How many floors is the building, and on what floor is the fire?

Caller: It's two stories high, and the fire is coming from the kitchen on the first floor.

Operator: Has the fire been extinguished?

Caller: I tried, but the fire is not out.

Operator: Is anybody injured or trapped?

Caller: Two people are trapped in the kitchen.

Operator: Have you evacuated?

Caller: A total of X staff and residents have evacuated.

\*When reporting a fire, the operator will ask various questions upon confirmation of the caller's safety. Be sure to confirm the questions you will be asked in advance so that you are prepared to answer calmly and accurately.

## 14 Ambulance

If you are suddenly taken ill or require urgent treatment in cases such as a traffic accident or injury, dial 119.

### Example phone conversation

Operator: Fire or ambulance?

Caller: Ambulance

Operator: What is the address where the ambulance should be sent?

Caller: 1-1 X Town, it's X nursing home.

Operator: What happened? Who needs help?

Caller: Mr. X, an X-year-old male suddenly collapsed.

Operator: Is he responsive? Is he breathing?

Caller: He is not responsive. He's not breathing either.

Operator: Please switch your mobile phone to speaker mode.

Caller: I have switched.

Operator: It is necessary to provide first aid (chest compressions, stop the bleeding, etc.).

[Provide first aid as instructed by the operator.]

Operator: Please guide the paramedics to your location. Tell me your name.

Caller: The staff will meet them at the entrance. My name is X.

\* Be sure to confirm the questions you will be asked in advance. When calling, having the facts organized will lead to a prompt request for emergency assistance.

\* It is necessary to provide information promptly, so if you are not confident in Japanese or if you don't know the address, have someone else make the emergency call.

## 15 Police

Should a traffic accident or crime occur, dial 110.

Trash and recyclables should be put out by 8 a.m. on the morning of collection at the designated trash collection point in your local area.

## How to dispose of trash and recyclables

Kasugai City practices separate collection of household trash and recyclables according to types. Residents are requested to keep designated trash collection points clean in consideration of others and observe the following points when disposing of trash and recyclables:

- Burnable garbage, non-burnable garbage, plastic containers and packaging materials, and metals (hazardous flammable items) should be disposed of in their respective designated bags, available at supermarkets and convenience stores.
- Separate trash and recyclables according to types for disposal at designated trash collection points.
- Trash and recyclables should be disposed of at the designated trash collection point of your local area. Where a bird net is installed at a collection point, make sure to place trash/recyclables under the net.
- Trash and recyclables should be put out by 8 a.m. in the morning of the day of collection. Do not put them out the day before. Trash or recyclables put out after the collection time will not be collected.
- Days of collection vary among local areas. Refer to the trash sorting app “San’aru (3R)” (install it from the QR code at right) or the Environmental Calendar (available at the city hall and other public facilities around the city).



- The following items should not be disposed of at designated trash collection points. (You are in principle charged for disposal)

Bulky waste (length of one side between 80 cm and 2 m; weighing under 50 kg)	For collection, contact the Public Sanitation Office. (Charge: ¥1,000 per piece, three pieces maximum per collection) Alternatively, you can bring bulky waste to the Clean Center by yourself. (Charged on weight)

## 18 Tax

### (1) Income Tax (National Tax)

[Income tax]

- Income tax is imposed on individual income earned for the one-year period from January 1 to December 31.
- Japan has seven income tax rates: 5%, 10%, 20%, 23%, 33%, 40%, and 45%, with higher income tax rates applied to higher levels of income.

### (2) Municipal Tax, Prefectural Tax, and Forest Environment Tax

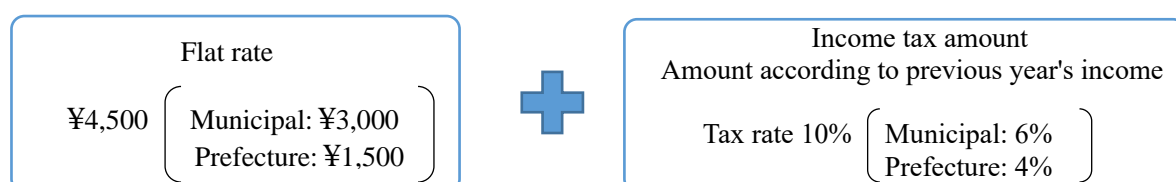

[Municipal and Prefectural Taxes]

Taxes paid to Kasugai City are called municipal taxes, and taxes paid to Aichi Prefecture are called prefectural taxes; together they are known as "resident taxes."

**Tax amount:** Tax is levied on income from the previous year (January 1st to December 31st).

It consists of a fixed flat-rate amount and an income-based amount.



• Municipal and prefectural taxes are paid by:

1. People who have an address in Kasugai City as of January 1st
2. People who have an address outside the city and have an office or house in Kasugai City as of January 1<sup>st</sup>

If you fall under either 1 or 2 and have income that exceeds the standard amount, you will be taxed.

\*In the case of 2, only the flat-rate amount of municipal tax and prefectural tax will be taxed.

[Forest Environment Tax (National Tax)]

This is a tax to ensure proper maintenance of forests. It is collected together with municipal and prefectural taxes.

Tax amount: ¥1,000

[How to pay taxes]

(1) Special collection from salary

Your place of employment (your workplace) deducts municipal and prefectural taxes from your salary and pays them on your behalf.

(2) Normal collection

You pay municipal and prefectural taxes yourself at financial institutions, convenience stores, and other designated entities by presenting a tax notice (tax payment slip) mailed by the City.

(3) Special collection from public pension

Municipal and prefectural taxes imposed on public pensions or the like received by people aged 65 or older are deducted from their benefits and paid on their behalf.

[Tax Treaty]

A tax treaty is a tax agreement between countries for the purpose of eliminating double taxation and preventing tax evasion and avoidance.

If you are an international student or business trainee from a treaty country and meet certain conditions, you may be exempt from income tax, municipal tax, or prefectural tax. The details vary by country, so please check the Ministry of Finance website.

[When you return to your country]

1. Designate a tax agent

A tax agent is a person who manages tax procedures on your behalf. When you leave Japan, be sure to designate a tax agent.

2. Pay the remaining tax

If you have any remaining taxes, you must pay them before you leave Japan.

If municipal tax, prefectural tax, and forest environment tax are deducted from your salary, you can pay them all together with your final paycheck. Please discuss this with your company.

If you are unable to pay the full amount before leaving Japan, a tax notice will be sent to your designated tax agent at a later date.

**(3) Light Motor Vehicle Tax (*keijidosha zei*) on Per Class Basis**

[Light Motor Vehicle Tax on Per Class Basis]

- The tax is imposed on individuals who own light motor-class vehicles, including motorized bicycles, small-sized special motor vehicles, light motor vehicles, and small two-wheeled motor vehicles as of April 1.
- The tax is levied by the government of the municipality where parking spaces, which are used exclusively by vehicle owners to park their light motor-class vehicles, are located.
- The amount of tax is determined on a per class basis, the date of the inspection for new vehicle registration, and other conditions.

#### **(4) Fixed Property Tax**

Fixed property tax is imposed on people who have fixed properties (lands, homes, and depreciable properties) as of January 1. The amount of tax is determined on the value of a fixed property and must be paid to the municipality where the fixed property is located.

#### **(5) Payment of Municipal and Other Taxes**

Revenue Section

Municipal and other taxes can be paid at financial institutions, convenience stores, and the city hall and its branches listed on the back of a tax payment slip. They can also be paid by bank transfer, credit card, and smartphone apps.

Moreover, fixed property taxes, as well as light motor vehicle taxes (on a per class basis) can be paid by scanning the eL-QR (commonly used QR Code to pay local taxes) printed on a tax payment slip via local tax payment websites (credit cards, internet banking, etc.), eL-QR compatible smartphone payment apps, and eL-QR compatible financial institutions nationwide.

If you fail to fully pay your municipal and other taxes by the due date, you will be charged a late fee on a daily pro rata basis until the date of full payment.

If you continue to fail to pay taxes, you will be subject to a penalty, such as seizure of personal property.

Therefore, if you are having difficulty with payments, please consult with the Revenue Section.

## 21 Pets (Rabies Prevention)

Environment Conservation Section

To prevent rabies, owners of dogs 91 days or older are required under the Rabies Prevention Act to register their dogs (once in the dogs' lifetime), to have their dogs receive a rabies vaccine shot once a year, and to attach a license and a shot completion form to their dogs.

Owners are also required to give a notification when the dog's address or owner changes due to moving or transfer or when the dog dies.
